#### **ART.1 HOSTING ISTITUTION DESCRIPTION**

The Observatory on Tourism for Islands Economy -OTIE- is a no-profit association involved on Research, Training Programs, Events, Conferences and Development Projects for islands.

The specific activities are focused on updating Databank on Insular Tourism, conducting studies and research works, organizing forums and seminars and participating in European projects on cooperation and social development for Islands. #### **ART.2 PLACE**

Candidates are required to be motivated, willing to work on the OTIE project and to have an excellent knowledge of the English (B2 of the Common European Framework of references). The knowledge of a second language (French, Spanish, German, Chinese, Arab) would be highly considered.

#### **ART.6 ACTIVITIES**

The candidate will deal with international relations, organization of scientific conferences and meetings. He/she will work - joining the projects' team - on research programs, supporting training course organization.

#### **ART.9 SELECTION PROCESS**

1st step: A commission composed by the Executive staff of OTIE will evaluate the applications received based on the following criteria:

- i. Curriculum vitae
- ii. motivational letter
- iii. knowledge of the languages
- iv. Skills in Event organization, Research, Eu Projects

2<sup>nd</sup> step: The Commission will contact you via e-mail in order to schedule a Skype interview.

3rd step: In case of selection OTIE will let you know within a week.

#### **ART.10 FACILITIES**

Candidates will be followed and supported by the company tutors in their entire learning and working process.

OTIE will provide to the trainee a 7,00€ daily meals voucher for the entire period of the internship.

The association will also cover the compulsory working insurance for the trainee.
